Admissions Fee A onetime non-refundable admission fee of \$300 will apply to all **NEW** TCA students. \$150 of this fee will cover the application fee for the first year.

Registration Fee

A yearly non-refundable registration fee of \$ 150.00 for each returning child or sibling is due at enrollment. In order to reserve a place in the student body, you must sign the contract below and return the fully completed and signed contract to the business office.

Tuition

Regular and full tuition per student from August to May is \$4,290.00. Discounts may apply for early payment or for multiple students from the same family.

If you pay in full on or before August 1, 2018 there is an 8% discount.

If you pay monthly, 10 equal payments of \$429.00 are due by the first of the month beginning August 1, 2018.

Additional children from the same family receive a 5% discount.

Mid-year enrollment: If your child is enrolled any time after August 1, 2018, the cost is \$429.00 per month plus the \$300 admission fee.

Permissions: Permission slips will be provided per field trip.

Billing Policy: Payments are due on the first of the month with the initial payment due August 1, 2018. If a payment is not paid on or before the 15th of the month, you may be charged a late fee of \$10.00 or 5% of the unpaid amount, whichever is less. We will not admit students to class at the beginning of the school year if their account is not current. We may also deny students the right to receive diplomas, transcripts, or final

exams if payments are in arrears. If this contract must be placed in the hands of an attorney for enforcement and/or collection, you agree to pay all costs of enforcement and collection (which shall include, but not be limited to, reasonable attorney's fees and costs) to the extent allowed by law.

Unconditional Obligation: The term of this enrollment contract is for the entire 2018-2019 academic year, and you are responsible for payment of the entire year's tuition and fees with no adjustment of charges in the event of absence, withdrawal or dismissal for any reason.

Student fee: We will charge one student fee yearly to cover; testing fees, fieldtrip expenses, a yearbook, science labs, and other school expenses. This amount will be determined at the beginning of every school year.

Payment: The preferred payment is personal check but we also except cashier checks, and cash. There will be a \$30 charge for all returned checks.

Severability: In the event that any portion of this enrollment contract is held to be invalid or unenforceable for any reason, the parties agree that said invalidity and unenforceability shall not affect other provisions of this enrollment contract, and that the remaining covenants, terms, and conditions or portions thereof shall remain in full force and effect, and any court of competent jurisdiction may so modify or amend the objectionable provisions so as to make it valid, reasonable, and enforceable.

Rules and Regulations of Trinity Classical Academy of Summerville: If we accept your enrollment contract, you agree to accept the rules and regulations of TCA that are stated above, or which appear in the student handbooks, catalogues, parent mailings, and any other written or verbal communications from us to you and the student. We reserve the right to deny enrollment or reenrollment or dismiss a student at any time during the school year if TCA officials determine for any reason that enrollment is not in the best interests of the school, which reason may include our determination that the conduct of the student, or of the parent or guardian, precludes a positive and constructive working relationship with teachers, administrators, or staff.

Agreement: I agree to pay the tuition payments indicated above plus all other school charges and fees and agree to the terms herein. Each person signing this contract below agrees to be responsible for the financial and other obligations set forth in the contract. By signing below, you represent that this contract is being entered into in the interest of your marriage or family. This contract will be interpreted according to the laws of the State of South Carolina without regard to conflict of laws principles.
