Admissions Fee

A one time, non-refundable admission fee of \$350 will apply to all NEW TCA students with the exception of new students whose siblings currently attend Trinity Classical Academy. New students whose siblings are currently enrolled in the school will pay the "returning students" registration fee of \$200.00.

Registration Fee

A yearly non-refundable registration fee of \$200.00 for each returning student is due at the annual re-enrollment period. In order to reserve a place in the student body, you must sign the contract below and return the fully completed and signed contract to the business office with the fee of \$200.00 per student.

Tuition

Regular and full tuition, per student, from August to May is \$4,500. Discounts may apply if the annual tuition is paid in full by August 1 or for multiple students from the same family.

If you pay in full on or before August 1, 2019 there is an 8% discount.

If you pay bi-annually, the first payment of \$2,250 is due by August 1, 2019 and the remaining \$2,250 is due by January 10, 2020.

If you pay monthly, 10 equal payments of \$450.00 are due by the first of the month beginning August 1, 2019.

Additional children from the same family receive a 5% discount.

Mid-year enrollment: If your child is enrolled any time after August 1, 2019, the cost is \$450.00 per month plus the \$350 admission fee.

Billing Policy: Payments are due on the first of the month with the initial payment due August 1, 2019. If a payment is not received on or before the 5th of the month, you may be charged a late fee of \$25.00. Unpaid tuition begins accruing additional late fees of 10% of the unpaid amount on the 10th of each month, in addition to the \$25.00 initial late fee. We will not admit students to class at the beginning of the school year if their account is not current. We may also deny students the right to receive diplomas, transcripts, or final exams if payments are in arrears. If this contract must be placed in the hands of an attorney for enforcement and/or collection, you agree to pay all costs of enforcement and collection (which shall include, but not be limited to,

reasonable attorney's fees and costs) to the extent allowed by law.

Unconditional Obligation: The term of this enrollment contract is for the entire 2019-2020 academic year. You are responsible for payment of the full annual tuition of \$4,500 and fees with no adjustment of charges in the event of absence, withdrawal, or dismissal for any reason and at any time during the year. If a student withdraws or is dismissed from Trinity Classical Academy, all tuition and fees paid at the time of withdrawal/dismissal are non-refundable and the balance of the tuition is due immediately upon withdrawal/dismissal.

Student fee: We will charge one student fee, yearly, to cover testing fees, textbooks, field trip expenses, a yearbook, science labs, and other school expenses. This amount will be determined at the beginning of every school year.

Payment: The preferred payment is personal check but we also accept certified checks and cash. Checks returned from your financial institution due to insufficient funds will result in a \$30 returned check fee, late fees as stated in the *Billing Policy* above and must be paid with a certified check.

Severability: In the event that any portion of this enrollment contract is held to be invalid or unenforceable for any reason, the parties agree that said invalidity and unenforceability shall not affect other provisions of this enrollment contract, and that the remaining covenants, terms, and conditions or portions thereof shall remain in full force and effect, and any court of competent jurisdiction may so modify or amend the objectionable provisions so as to make it valid, reasonable, and enforceable.

Rules and Regulations of Trinity Classical Academy of Summerville: By signing below, you agree to accept the financial policies of TCA that are stated above, and all policies and procedures which appear in the student handbooks, parent mailings, and any other written or verbal communications from us to you and the student. We reserve the right to deny enrollment or re-enrollment or dismiss a student at any time during the school year if TCA officials determine for any reason that enrollment is not in the best interest of the school, which reasons may include our determination that the conduct of the student, or of the parent or guardian, precludes a positive and constructive working relationship with our teachers, administrators, staff, or other students enrolled at TCA.
